WED 10:45 – 12:00 Executive Room [In-Person Session] Syndemic Approaches	We Only Know What We Collect: Data, Evaluation, and Meaningful Inclusion Community Voices and Experiences	Data informs our work, from recommended best practices to allotment of funding. We rely on the data collected from the populations we wish to serve. How do we gather data that is timely and relevant? How do we best evaluate data so that it is consequential for the community from which it is gathered? Meaningful inclusion of an impacted community is more than gathering information. It is giving voice to the experience and expertise of people within that community so that it guides our work each step of the way, from data collection to evaluation and program planning. This session explores the challenges that arise in data collection when the communities impacted most are not meaningfully included in planning.
WED 10:45 – 12:00 Congressional A [In-Person Session] Hepatitis	Who's Watching the Baby? Perinatal Hepatitis B and C	According to the CDC's Division of Viral Hepatitis (DVH), a total of 17 perinatal hepatitis B cases were reported through NNDSS to CDC during 2019. Among the 9,950 infants born during 2018 and managed by 64 jurisdictions in the Perinatal Hepatitis B Prevention Program, 97% had received recommended prophylaxis at birth; among those with post- vaccination testing, 23 were cases of perinatal hepatitis B transmission. A total of 217 perinatal hepatitis C cases were reported to CDC during 2019, the second year that standardized surveillance for perinatal hepatitis C was conducted by states and case notifications submitted to CDC. This session will explore different approaches to perinatal hepatitis B and C by several jurisdictions, including the stark reality that racial inequities start at birth for these babies.
WED 10:45 – 12:00 Congressional B [In-Person Session] ADAP	Health Coverage in Flux: Priorities for Uninterrupted Access to Care and Treatment in 2023	This session will provide an overview of health coverage policy changes programs can expect in 2023 and how Ryan White HIV/AIDS Program (RWHAP) Part B/ADAPs can prepare. The session will include a discussion about the ending of the COVID-19 Public Health Emergency and the unwinding of the Medicaid continuous coverage requirements. The session will also highlight the growing importance of Medicare for RWHAP/ADAP clients and strategies to navigate that program. This session will be discussion-based, with ADAP staff participating as panelists, and will include a facilitated discussion of best practices for RWHAP Part B/ADAPs.

This session will feature a panel of experts who will highlight the barriers to healthcare and wellbeing imposed by drug criminalization laws and explore policy solutions that will bring us closer to ending the syndemics of HIV/AIDS, viral hepatitis, and substance use disorder and drug poisoning. State behavioral health agencies, along with opioid and other substance
Forum Room [Hybrid Session] Hepatitis	Services with Drug Treatment Programs in Collaboration with Behavioral Health Agencies and Treatment Providers	use disorder treatment programs, are critical partners in efforts to expand viral hepatitis screening, care, and treatment. However, many health department programs experience challenges engaging these stakeholders and encounter both program-level and system-level barriers to implementation. This session will focus on successful collaborations across agencies to integrate viral hepatitis services into substance use disorder treatment programs.
WED 10:45 – 12:00 Cabinet Room [Hybrid Session] ADAP	Maximizing ADAP Engagement and Utilization in EHE Implementation	Despite the lack of an ADAP-specific Ending the HIV Epidemic (EHE) funding stream, ADAPs are instrumental in state and local jurisdictions' capacity to meet EHE goals. ADAPs and Part As across the country are developing partnerships to provide rapid access to anti-retroviral therapies (ARTs), coordinating services, and developing innovative strategies to maximize EHE funding flexibilities, including for the creation of housing and other support services. In addition, ADAP infrastructure has been instrumental to the implementation of pre- exposure prophylaxis (PrEP) assistance programs, which are critical to population-level PrEP access. This session provides an overview of the strategies and tactics that ADAPs are exploring to meet National HIV/AIDS Strategy (NHAS) and EHE goals.

As health departments try to balance the focus on addressing MPV, as well as ensuring work on HIV and hepatitis continues, lessons have been learned about the incorporation of other infectious diseases into HIV and hepatitis programs. This session will provide an overview of strategies and challenges of integrating prevention, care, and treatment programs.





WED 3:15 – 4:30 Cabinet Room [Hybrid Session] Hepatitis	BIPOC Leadership Development in Hepatitis: MLP Hepatitis Staff Experiences	NASTAD's Minority Leadership Program (MLP) serves as a space, rooted in social justice, for health department staff of color to engage in critical conversations about job advancement, overcoming institutional barriers to equity, managing emotions and burnout, identifying racial and gender-based microaggressions and triggers, successful staff and project management, effective communication, and more. Considering the vastly underfunded programming for prevention and surveillance activities for hepatitis, it would be a win-win to further expand MLP. This session will discuss the impact of MLP from the perspective of alumni and why MLP needs to expand if we are to reach elimination of hepatitis by 2030.
WED 3:15 – 4:30 Senate Room [Hybrid Session] Syndemic Approaches	CDC, SAMHSA, Tribal Health Authorities, and Opioid Settlement Funds, Oh My!: Coordination Across Federal Agencies and Funding Streams to Create Comprehensive Drug User Health Services	This interactive, strategy session will explore the emerging, and often complex interconnected relationships across federal and jurisdictional agencies, including distribution of recent opioid settlement funds, that support a range of drug user health services. We intend to highlight the challenges, facilitators, and opportunities presented by these complementary partnerships and the complicated weave of funding and support services needed to truly reach comprehensive care for people who use drugs. NASTAD's Drug User Health Team will facilitate a listening and dialogue session to discuss current disbursement of opioid settlement funds, emergent federal funds directed towards harm reduction and SSPs, blended funding strategies, and challenges/facilitators to meaningfully getting resources to harm reduction programs.

Implementing these medicines has not been without important challenges by many ADAPs. This session will highlight policies and procedures implemented by state/territorial ADAPs and will provide an opportunity for attendees to share best practices associated with maximizing access to these products.
THU 10:45 – 12:00 Executive Room [In-Person Session] Syndemic Approaches	Criminalized Substance Use of Pregnant People and Parents: Navigating Health and the Criminal Justice System	This session will reflect on the structural racism that underlies the war on drugs, inhibiting access to healthcare for pregnant people due to ongoing attempts to criminalize substance use during pregnancy. We will hear about the unique movement of Women on the Rise Telling HerStory (WORTH), an association of currently and formerly incarcerated women who have been empowered by their experiences to personally share about health or criminal justice authorities and barriers to treatment.
