Harm Reduction Outreach Specialist PT

Position

The Harm Reduction Outreach Specialist is a Des Moines, IA based position with the Iowa Harm Reduction Coalition (IHRC). This part-time position involves a combination of street-based, fixed-site, and mobile outreach to people who use/inject substances in Central Iowa communities, and coordination of advocacy initiatives within drug user communities.

Description of Duties

- Participate in a mix of street and fixed site (office) based harm reduction outreach.
- Lead a team of volunteers.
- Provide access to safer injection materials.
- Provide access to overdose prevention materials + naloxone.
- Identify new outreach sites and work with community members to advertise outreach activities to directly impacted people.
- Be culturally aware of people who use drugs and respect their decisions (Peer Recovery Certificate or willing to be trained).
- Provide community based STI/HIV/hepatitis prevention education to MSM, drug users, sex workers and those at high risk of getting sexually transmitted infections.
- Provide safer drug use and safer sexual health education.
- Provide referrals to medication assisted treatment, detox, other substance use treatment services, housing programs, and health care services.
- Distribute STI/HIV/HCV prevention materials.
- Provide information about HIV/HCV/STI care and treatment services.
- Conduct Medicaid enrollment, rapid re-housing screening, and buprenorphine treatment eligibility assessment.
- Document all client interactions and enter all participant data into the reporting system.
- Administer HIV / HCV counseling and testing, and provide referrals to treatment (phlebotomy certificate or willing to be trained).
- Engage, mobilize, and organize community members and IHRC clients to participate in syringe access and harm reduction advocacy activities.
- Participate in staff meetings and board meetings in person or by phone / web and participate in monthly staff meetings.
- Advance professional knowledge of drug policy and public health policy through participation in webinars, attending national and regional harm reduction conferences, maintaining relationships with national-level organizations.
- Compile naloxone and safer injection kits.
- Maintain strict confidentiality and treat all clients and participants non-judgmentally and with positive regard.

Qualifications

- We are specifically looking for candidates with an active interest in Harm Reduction, and social justice as it pertains to individuals who use drugs, do sex work and/or are at risk for HIV, hepatitis, overdose, or incarceration.
- Must be able to work independently. IHRC employees often work remotely and employees must be able to be organized, self-motivated team-players, with strong interpersonal skills, excellent written and oral communication skills, and the ability and willingness to be hands-on and solve problems as they arise.
- Must demonstrate commitment to harm reduction principles and to working with people who use drugs in a multicultural, multi-racial environment in a non-judgmental manner.
- Fluent in Microsoft Office applications.
- Must be able to work flexible hours.
- Must have a valid driver's license and auto insurance.
- People who are HIV/hepatitis positive/undetectable, lived experience of drug use, sex work, or incarceration are strongly encouraged to apply.
